Marty is looking for volunteers to help with the car show. He also had club hats for \$12 that Midwest Monograms had made.


**50/50 Raffle:** \$60was won by one or our racing queens- Tammy Fast Ball Walker! She donated it back to the club. Thank you Tammy!



**Purpose:** To enjoy the Corvette through association with other Corvette owners. To have fun on many levels through social events, road trips, car shows, charity events and competition as each person wishes. To actively promote and work for the advancement of "Saint Louis Corvette Club" and its activities. To respect the differences and wishes of each Saint Louis Corvette Club member.

Proposed Revision: Article I, Section 2: PURPOSE OF THE CLUB

**Purpose:** To enjoy the Corvette through association with other Corvette owners. To have fun on many levels through social events, road trips, car shows, charity events and competition as each person wishes. To actively promote and work for the advancement of "Saint Louis Corvette Club" and its activities. To respect the differences and wishes of each Saint Louis Corvette Club member. <u>To promote, and participate in, the activities of NCCC.</u>

#### **<u>Current:</u>** Article III, Section 2: **MEMBERSHIP STATUS** (5<sup>th</sup> bullet)

NCCC Membership: Any person who has paid dues to the NCCC and abides by the by-laws will be extended all of the rights and privileges offered by the NCCC.

**Proposed Revision:** Article III, Section 2: **MEMBERSHIP STATUS** (5<sup>th</sup> bullet)

NCCC Membership: All Saint Louis Corvette Club members will be NCCC members and will be extended all of the rights and privileges offered by the NCCC.

#### **Current:** Article III, Section 3: **MEMBERSHIP FEES**

Membership dues for Corvette owner members shall be \$20.00 per person plus NCCC dues and an optional \$10.00 for "NCCC spouse" upon application for membership. This fee is to be paid prior to the November meeting. New members joining between September 1 and November 1 will be considered paid through November of the following year. Honorary members and club sponsors are exempt from these fees.

#### Proposed Revision: Article III, Section 3: MEMBERSHIP FEES

Membership dues for Corvette owner members shall be \$20.00 per person plus NCCC dues upon application for membership. This fee is to be paid prior to the start of the November meeting. New members joining between June 1 and August 31 will pay one half (½) current membership dues plus NCCC dues upon application for membership. New members joining between September 1 and November 1 will be considered paid through November of the following year. Honorary members and club sponsors are exempt from these fees.

Subject: Re: October Governors report

What a great organization we have created.

Hard to believe we are approaching the end of our third year as the newest (and best) Corvette Club in the St. Louis area.

Last October we worked with "Route 66 Corvette Club" to sponsor 10 speed events over 2 days at the GM assembly plant in Wentzville. At these events we provided all the food, BBQ, utensils, tents, generator, etc. and personnel to offer food to the racers for both days. For this effort the club grossed approximately \$100 in profits. Thanks to Bill Dotson - our chief cook for both days - and several other club members we were able to keep most people happy with our food service.

We also provided some "corner workers" on Sunday to help run the events. We split the profits from the speed events at a 30-70% ratio. Since Route 66 provided all the timing equipment and most of the knowledge and manpower to staff the events it seemed like a reasonable split for the profits. We realized approximately \$700 profit for our efforts for these 10 weekend speed events.

This year the Route 66 Corvette Club is providing the food service as they are much closer to the event and can provide the required personnel, food and equipment to staff the food booth much easier than we can.

Route 66 Corvette Club still has the timing equipment that was used for last years events but has decided to contract the timing of the events to another Corvette Club for \$300. This is not a large sum of money but some of our profits will be used for this additional expense. Apparently there is a large expense to purchase software to be able to use the timing equipment for this type of event. This year we are still splitting the profits at a 30-70% ratio.

For next year, Route 66 Corvette Club is proposing the same 30-70% split as in the past. Since we will be providing our club sanction numbers and additional personnel for the weekend I propose we offer to split the profits at 40-60% for the weekend. We will be providing almost the same amount of personnel, time, and

There is a governors planning meeting in November when all clubs submit their proposed event schedule for the upcoming year. At our next meeting we need to discuss if we want to continue working with Route 66 next year, the amount of split and if we want to schedule events other than speed events.

Tulsa, Oklahoma has submitted a proposal to host the NCCC National convention from June 21-27, 2008. They will have speed events, Concours, Peoples Choice Car show, Funkhana, Drags, Rallye and several parties. Something for everyone!!

The outdoor pool is heated so if you feel brave you can jump in and enjoy the cool outdoors.


We use channel 6-6 on the small family radios. There is one more club meeting before we leave but if you want to discuss let me know anytime.
